2. The supplier should ensure the registration certificate is submitted together with the quotation
3. Supplier must be financially stable and should be willing to provide goods on 30 days credit term.
4. Prospective firms must have carried out successful supply and delivery of similar goods/services to institutions of similar size and complexity.
5. **Eligible suppliers. The procuring entity's employees and their relative (spouse and children) are not eligible to submit the quotations**
6. The quotation should be signed and it should the contact of the firm willing to supply the drugs

**Deadline:** All the bids should be received not later than 22 June 2017 at **12 Noon** Somali Time.
