I. INTRODUCTION

1. *The International Rescue committee*

The International Rescue Committee, hereinafter referred to as “the IRC”, is a non-profit, humanitarian agency that provides relief, rehabilitation, protection, resettlement services, and advocacy for refugees, displaced persons and victims of oppression and violent conflict. The IRC has been operating in Somalia since 2007. IRC is among the numerous organizations assisting Somali populations to address their basic humanitarian needs, while trying simultaneously to support localized longer term opportunities. With a strong foot print in South Galkacyo (since 2007), Mogadishu (since 2011) and Garowe (since 2012), the IRC has developed a solid humanitarian portfolio in the field of Health, WPE, WASH & Livelihoods. In addition, the IRC has piloted local governance programming (CDR) in Puntland as a way to bridge local participation and community development, at a time the New Deal/Compact¹ is starting to kick off its state building & peace building objectives.

2. *The Purpose of this Request for Proposal (RFP)*

It is the intent of this RFP to secure competitive proposals to select a service provider for the International Rescue committee Somalia Program to provide services from Nairobi and Mogadishu. All eligible Suppliers and Vendors that are qualified and are technically competent for the supply of the services in the price list schedule as per various categories provided below and in the annexes are invited to submit their proposals.

The winning bidder(s) will enter into a fixed price Master service agreement (MSPA) for one (1) year. Bidders shall be domiciled and must have complied with all Government legal Regulations to operate in Kenya and Somalia and a regular tax payer to offer such services as specified in the tender and shall furnish copies of their operating license/certificate of registration valid for the fiscal year 2018. The Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices.

3. *Cost of Bidding*

The Bidder shall be responsible for all costs associated with the preparation and submission of its bid, and IRC hereinafter referred to as “the Purchaser”, will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

II. THE BIDDING DOCUMENTS:

4. *The Bidding Documents*

The Bidder is expected to examine all instructions, forms, **terms** and **specifications** in the bidding documents prepared for the selection of authorized suppliers or vendors. Failure to furnish all information required as per the bidding documents or to submit a bid not

substantially responsive to the bidding document in every respect will be at the Bidder's risk and may result in bid rejection.

The Bidding document comprise of the following documents:

- The Request for Proposal – RFP (*this document*)
- ***Categories of Services.***
- ***List of Locations to which the services will be delivered.***
- ***Price Offering sheet as provided in the Request for Quotation.***
- *Annexes with:*
 - *Supplier Information Form*
 - *IRC Code of Conduct, and*
 - *Supplier Conflict of interest form*

5. Clarification of Bidding Documents

A prospective Bidder requiring any clarification of the Bidding Documents may notify the Purchaser in writing at the SO-Procurement@irc.org. The request for clarification must reach the purchaser not later than **18TH May 2018**. The Purchaser will respond by e-mail providing clarification on the bid documents on the **21st May 2018**. Written copies of the Purchaser's response (including an explanation of the query but without identifying the source of inquiry) will be communicated to all prospective Bidders, who had received the bidding documents.

III. PREPARATION OF BIDS:

6. Language of Bid

The bid and all relative correspondence and documents exchanged between the bidders and the Purchaser shall be written in **English language** only. Any printed literature furnished by the bidder and written in another language must be accompanied by an English translation of its pertinent passages, in which case, for purposes of interpretation of the bid, the English translation shall prevail. Any translations must be performed by a licensed translator as recognized and notarized by the Courts and Government of Kenya.

7. Documents Comprising the Bid

The submitted bid must include the following information. Failure to supply all requested information or comply with the specified formats may disqualify the bidder from consideration.

- Cover letter explaining interest to be a contracted vendor or supplier
- A Bid Document detailing the services against unit prices on the sheet provided.
- Profile of the Bidding Company (5 pages maximum) with a brief description of the firm's organization; Recent Contracts completed; Company Organization Structure; the profiles of Key staff.
- Certificate of Incorporation and or Registration in Kenya or Somalia.
- Tax Compliance Certificate/Evidence of Paying tax to any authority in Kenya or Somalia
- PIN Registration Certificates in Kenya/Evidence of Registration as a tax payer in any region in Somalia
- Bank details and Financial Statements from a reputable Bank in Kenya or Somalia.
- IATA Registration documents as an Air transport service provider.

- License as a Clearing and Forwarding Agent in Kenya and or Somalia.
- Evidence of membership with recognized clearing and forwarding Association in Kenya or Somalia
- Cumulative Flight Hours of the Pilot(s).
- The Frequency/Number of Freights per week to Mogadishu, Garowe, Galkacyo, Dhusamareb, Guriel. Flexibility to provide ad hoc freights on request. Please provide the number of freights in the past six months to Somalia.
- Size of airworthy fleet, type of aircraft and registration numbers
- Authority to land and or takeoff in Kenya and Somalia.
- Submit an Air Operator Certificate (AOC) valid in the year 2018/2019.
- Maintenance records for the Aircrafts to be used in the operations.
- Three (3) References from current or past clients (at least in the last one year)
- Intent to bid form, completed and signed
- Supplier information form, completed and signed
- IRC Conflict of Interest and Code of Conduct form, completed and signed

8. Bid Prices & Price Changes

For the purpose of selecting a supplier/vendor and executing the Master Service agreement, the Bidder shall clearly indicate the unit price of the services they want to offer. All unit prices shall be clearly indicated in the space provided in the price schedule. The Bidder must sign and officially stamp the price schedule.

During the validity period of the Master Service agreement, if there is a price change in the market the **supplier can express the change in writing for the Purchaser a month before implementing the change.** The Purchaser also responds for the request in writing within 15 days of receipt of notice for price change. Once the changes are agreed between both parties, an addendum will be signed and included in the MSA.

9. Bid Currencies

All rates and amounts entered in the Bid Form and Price Schedule and used in any documents, correspondence or operations pertaining to this tender shall be expressed in United States Dollar (USD).

10. Document Establishing Services' Eligibility and Conformity to Bidding Documents

Pursuant to *Clause 8*, the bidder shall furnish, as part of its bid, documents establishing the eligibility and conformity to the Bidding Documents of the services, which the Bidder proposes to offer under the Contract.

The Documentary evidence of the services' conformity to the Bidding Documents may be in the form of technical specifications, literature, drawings, data (tables, graphs etc.), and shall furnish:

- A detailed description of the services' essential technical and performance characteristics.
- A **clause-by-clause** commentary on the Purchaser's Technical Specifications demonstrating the goods' and services' substantial responsiveness to those specifications or a statement of deviations and exceptions to the provisions of the Technical Specifications.

The bidder shall note that standards for workmanship, material and equipment, and references to brand names or catalogue numbers designated by the Purchaser in its scope of work are intended to be restrictive. However, the Bidder may substitute alternative standards, brand names and/or catalogue numbers in its bid, provided that it demonstrates to the Purchaser's satisfaction that the substitutions are substantially equivalent or superior to those designated in the Technical Specifications.

11. Bid Security

For the Purpose of This Tender or MSA Process, Bid Security or Bond is not applicable.

12. Period of Validity of Bids

Bids shall remain valid **for 90 working days** after the date of bid opening prescribed by the Purchaser, a bid valid for a shorter period may be rejected by the Purchaser as non-responsive.

In exceptional circumstances, the Purchaser may request the Bidders to extend the period of validity. The request and the responses thereto shall be made in writing by letter or e-mail. A bidder agreeing to the request will not be required nor permitted to modify his bid.

13. Format and Signing

The original bid shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to the contract. Financial proposal pages of the bid shall be initialed by the person or persons signing the bid and stamped with the company seal.

Any interlineations, erasures, or overwriting shall be valid only if they are initialed by the person or persons signing the bid.

The bidder shall include a cover letter in their proposal. The content of the cover letter shall include the following information:

- A table containing bid offer: item description, unit price
- A detailed specification of the offered services
- Warranty (if necessary and appropriate);
- Flight Schedules between Nairobi and or Mogadishu to various destinations in Somalia and their flexibility
- Price validity date (for this purpose and as stated on the advertisement, quote given shall remain unchanged for 90 working days).

IV. SUBMISSION OF BIDS

14. Submission and Marking of Bids:

Bidders shall submit sealed bids addressed to the:

by **24th May 2018 at 5.00pm East African Time**. All bids are to be dropped in the Tender Box at the reception areas. Bids submitted after the deadline will not be accepted.

Bidders must sign the bid register form at the reception of the office indicating their company name, telephone number, and date of submission.

15. Modification and Withdrawal of Bids

The Bidder may modify or withdraw its bid after the bid’s submission, provided that written notice of the modification, including substitution or withdrawal of the bids, is received by the Purchaser prior to the deadline prescribed for submission of bids.

The Bidder’s modification or withdrawal notice shall be prepared, sealed, marked, and dispatched. No bid may be modified after the deadline for submission of bids.

V. BID OPENING AND EVALUATION

16. Preliminary Examination

The Purchaser will examine the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether bids are generally in order.

17. Evaluation and Comparison of Bids

Bids determined to be substantially responsive as per **section 7** above will be considered for the evaluation process with the below scoring criteria.

18. Contacting the Purchaser

Subject to **Clause 5**, no Bidder shall contact the Purchaser on any matter relating to its bid, from the time of the bid opening to the time the Contract is awarded or selected authorized supplier or vendor is announced.

19. Notification of Award

Prior to the expiration of the period of bid validity, the Purchaser will notify the successful bidder in writing or where necessary by phone that his/her bid has been accepted and, selected for Master service agreement for the specific goods and/or services. At this stage IRC may also choose to negotiate with the selected bidder to finalize the offer.

VI. CONTRACTING

20. Contract award and notification

The Purchaser will award the Contract to the notified successful Bidder(s) whose bid has been determined to be substantially responsive and has been determined as the best evaluated bid considering price/performance factors, provided further that the Bidder is determined to be qualified to enter into Master Service agreement and perform its obligations satisfactorily.

21. Warranty

The Supplier warrants that the goods to be supplied are new, unused, of the most recent or current models (products), and meet Purchaser’s specifications. The warranty shall remain valid for a period of time as may be specified by the supplier in the Bid and this warranty period shall be considered as one of the bid advantages, and shall in no case be less than that which is provided for by Kenyan Law if any.

22. Inspection

The Purchaser shall have the right to inspect the goods to confirm their conformity to the specification. The inspection will be conducted by assigned staff of the Purchaser or a reputed relevant consultant selected by the Purchaser.

In the future business relation, should any inspected goods fail to conform to the specification, the Purchaser may reject them and the Bidder shall replace the rejected goods without extension of time except at the Purchaser's sole discretion.

23. Price Schedules and Location

Vendors interested in the provision of services to IRC Country offices should NOTE that all categories apply to all IRC Offices.

24. Service or consultant agreements

For service or consultant agreements time and material awards are not authorized unless it is the only suitable award and a ceiling is established.

Disclaimer

The Purchaser reserves the right to alter the dates of the timetable.

The Purchaser does not bind itself to accept the lowest or any proposal.

Ethical Operating Standards
